#### **Administrative Structure**









The Strategic Fiker Center for Studies has published many research studies during the year 2020, The topics were chosen with great care; keen to add value and to meet a cognitive-scientific need in those thorny areas, given this the research team encountered many difficulties during the research phase, but with the testimony of the Scientific Arbitration Committees - specific additions were made.

The center succeeded in supplying the library with new materials rich in its topics and accurate in its methodology, and this has been proven through increased demand for publications of the Center, and the interaction of the visitors during the participations in the book exhibitions in 2020.

#### **Economic developments in Saudi Arabia**

This review deals with developments of the economic situation in Saudi Arabia, particularly in recent years, and the impact of this socially and culturally, and on the Saudi citizen. It also addressed the steps taken by the Saudi government towards economic diversification and on relying on other sources of income besides oil. These include investment in the manufacturing industry, retail trade, the communications and information technology sector, the construction sector, as well as others.

The study employed an extensive analysis of the magnitude of the decisions taken by Saudi Arabia to facilitate local and foreign investment, restructuring some administrative institutions; as well as decisions related to fiscal and financial policy. The study looked at the steps taken by the government to increase the effectiveness and efficiency of human resources in the Kingdom, with a vision to integrate them widely into the Saudi market, which is witnessing developments day by day.





#### **Coronavirus crisis**

This review provided an in-depth comprehensive reading of the implications of the coronavirus crisis and its outlook. It dealt with the role of societal, partisan and government actors in addressing the crisis; the methods of dealing with the crisis, extrapolating the implications of that on governance structures, in addition to deducing intellectual approaches and political and media discourse about the coronavirus. The study touched on China's diplomatic economy, before and after the crisis, and China>s investment in its technological progress. It also provided a historical reading of the interaction policies of US decision-makers with the various major international crises / variables, concluding with the expected scenarios for the coronavirus crisis.

#### **Turkish Conservatives**

This review discussed the historical roots of the conflict between religiosity and Westernisation in Turkey and the approaches and tools of the conflict between the two currents; and addressed how Turkish society dealt with its various political, social and cultural components, its relationship to religiosity, and the reasons behind this. It examined popular religious entities, including groups, parties and institutions, including endowments amongst others, and their role in the religiosity of society, as well as their handling of the state and its role in the religiosity of society. After delving into the study of official institutions concerned with Islamic values in society, such as the Directorate of Religious Affairs, the Religious Endowment and others, as well as the relevant laws, the study concluded with an assessment of the future of the conservative trend in Turkey.






#### **Schools of imams and preachers**

The study dealt with the administrative, educational and financial system of the schools of imams and preachers, with an explanation of the intellectual and theoretical dimensions found in these schools. It further monitored the internal and external influences of these schools in Turkey, and their relationship to the formation of a philosophical intellectual view outside the scope of general Turkish society. The study illustrated the reciprocal relationship between Turkish society and the schools of imams and preachers, and the possibility of benefiting from experiences outside Turkey.



#### **Arab Gulf States;** Rises in global indices 2019 - 2020

This review examines the Arab Gulf states in the most prominent global indicators for the year 2020-2019 by reviewing more than ten global indicators that are credible, objective and methodically accurate. The most prominent of these indices are the Bertelsmann Index, the Human Development Report, the Prosperity Index of the Legatum Foundation, the Global Innovation Index, as well as other 2019 indicators. To become acquainted with the various dimensions of the research topic, the author utilised the various mechanisms of information gathering and analyses employed by international institutions, which in turn contain high levels of global knowledge and financial hegemony. Moreover, the study sought to present the factors and policies that enabled most Gulf countries to be ranked first in the world, as well as extrapolate the challenges and obstacles therein. The study defined the conditions and criteria for evaluation in the various indicators of the selected country that are acknowledged confidently by decisionmakers, research centres and world media. General conclusions were extrapolated on the position of the Gulf states in seven major areas (e.g., governance, transparency, economy), and manifestations of a qualitative shift were revealed and presented statistically, in addition to an overall and comparative presentation between the various Arab Gulf states.





#### **Bertelsmann Transformation Index**

The Bertelsmann Transformation Index atlas, which was translated into Arabic by the Strategic Fiker Center for Studies, deals with the transformation of strategies adopted by governments for governance, through a research methodology based on the collection of quantitative and qualitative data, and re-analysing them according to their historical development. The Bertelsmann Institute monitored data on transformation indicators in 129 countries from all continents in 2020, and the Strategic Fiker Center for Studies translated the country reports of the six Gulf countries.

#### The art of judgment;

Refinement of Imam Mawardi Al-Shafi's book 'Tashil al-nazar wa-ta'jil al-zafar'

The book Tashil al-nazar wa-ta-jil al-zafar is an advanced-level complex text with sobriety. It is from the socio-political analytical works, which quickly reach the depths of political experience, leaving the reader admiring the realist ideas that are suitable for our time, as if the author was a senior expert in political work.

However, Imam Al-Mawardi (1058-972) wrote it for his era, and therefore, some methodological defects can be identified. From extensive unnecessary extrapolations and long quotes and examples that the author employed, a process of refinement of this deep text had to be undertaken according to a methodologically balanced and succinct method to make it approachable and accessible to all.

This was named 'The Art of Governance' so that this simple title may appeal to the reader, and its content can be directly understood, as intended by Al-Mawardi.

#### Challenges in controlling natural gas reserves;

Map of the eastern Mediterranean conflict This study discusses the changes related to the global natural gas market, as well as the political balances resulting from the conflict over the areas of natural gas production and transportation. It also discusses the ongoing conflict in the eastern Mediterranean basin due to the dispute over the areas of border demarcation, and international interventions by some major countries to impose their influence upon this important region. Tunisia is one of the most stable countries in the Arab Spring since the January 2011 revolution. This relative stability allowed it to enter into a new dynamic and helped it in the transitional process. Even though the multiparty system in the country suffered from a major bottleneck before the revolution, the political arena changed afterwards, and the restrictions on party pluralism have been lifted.

This review deals with the most prominent intellectual, political and sectarian trends in Tunisia, especially those that are active and have had a parliamentary presence since the revolution. In order to approach these components and reorganise them according to the relevant ideology, the study divided them according to the broad currents: leftist, nationalist, liberal and Islamic.

# Military bases in the Middle East;

Military role and the intertwining of interests

This study examines the issue of military bases in the Middle East region in general, and the Arab region in particular; what their roles and functions are; how they were differentiated and established within the political changes the region witnessed; what is the map of military presence of the various competing forces; and what are the competing forces. When populations are afflicted by the grip of oppression and poverty, and dominated by tyranny and corruption, they begin to search for new means to avoid what can be avoided, and often the primary desire is within the framework of the ruling system itself, hoping to reform it from within. Such populations configure their demands in the form of press releases, comments and statements of opposition. It may escalate to the level of rallies, workers> strikes or collective resignations, and then develop into protests with demands, that may transcend further into fill-blown revolutions.

This study is limited to analysing protests that took place in 2019, and the end of 2018, that had legitimate demands and wanted to cause a change in the structure of the existing Arab regimes, namely the protests that took place in Sudan, Algeria, Iraq and Lebanon.

#### IHH Humanitarian Relief Foundation;

Foundation and experience 2020-1992

This study aims to provide a reading of IHH's experience, its evaluation, and contribute to developing the work of civil society organisations. It does this by focusing on institutional values and the necessity of merging between emergency relief projects and sustainable projects, whose outputs can provide innovative solutions to the problems faced by their societies. In its three chapters, this study discusses the nature of conflicts in the southern and eastern governorates of the Republic of Yemen.

The first topic, following the introduction, deals with a map of the local actors, in terms of the geographical presence of the active forces, their political objectives, their strengths and weaknesses, and their external links.

The second topic, the essence of study, focuses on regional and international actors in the Yemeni arena, especially in the south and east of Yemen, where the study examines the objectives of those regional and international powers, what the appeal is for them, as well as the magnitude of their capabilities and quality of their tools in implementing their policies, achieving their interests and enhancing their influence. Furthermore, the study addresses the implications for the nature and level of the powers' relationship with local parties, the effectiveness of their influence on interactions, and their role in ongoing conflicts.

In the third topic, the study seeks to foresee the future.

The importance of this study stems from the fact that it addresses an important development and economic dimension in light of the economic and social transformations in the Kingdom, especially with the first steps in promoting a culture of reducing the Saudi citizen>s dependence on the state and living as a consumer, and moving to the idea of living as a productive citizen to increase sources of national income.



The Fiker Center launched the Encyclopaedia of Islamic Political Jurisprudence project. This project aims to have a contribution in modernising Islamic political heritage, broadening horizons for its development and linking it to contemporary generations and modernday issues. This is in the endeavour to integrate Islamic political thought into political thought and philosophy, drawing attention to what the Islamic intellect produced in previous eras and the possibility of benefiting from it today. The project is supervised by a group of prominent scholars and thinkers.


The Center's website is designed to suit the expansion of its work and cope with the modern specifications of websites in terms of speed of browsing, upgrading the protection and security, the rapid response to browsing and the updates related to technological development. The website has achieved a %150 increase in terms of visits compared to last year The Center has also achieved progress concerning the search engines and it appears on The first page of the Google search engine through more than 80 keywords. The website enables its visitors to access to the Center's latest news, activities and publications, as well as research papers such as researches, political papers and position papers. The Center's website is one of the most useful websites of the Arab research centers. It enables its visitors to download researches, political papers and position papers for free in order to expand the circle of beneficiaries.



The Center runs two pages on Twitter and Facebook that post its publications for followers The two pages contact them and answer their questions and inquiries daily through tweets ranging from 15 to 20 per day.






